Public comment #1

City update by Randy Looper – Woodbury development is still under consideration and will be discussed at the April meeting. Housing at the old hospital site is still on schedule. Grant was received for the industrial park. Permission has been received to run a pipe under the Yampa River to the other side for future development. Yampa Valley study on rail is having a meeting tonight, Available on zoom (5:30-7:30pm).

Did MCTA form a committee for YVRA visitor site? – Not yet.

Larry Hoover – gave input on the 3-sign project on the agenda. No sign on the Utah state line.

### **Budget**

Under contingency – state match that we needed to return was not able to be put under last year's budget – so it has been deducted from this year. Five thousand dollar donation is not shown on the budget as the Commissioners only make adjustments once each quarter.

No Board member expenses were reported.

- Connor Hall State Outdoor Recreation head coming with a film crew for 3 days during tourism days for production on PBS. We can use the footage for other things. He wants to be actively involved in various opportunities, on a horse, raft, bike, atv, etc. The only cost to MCTA is for rooms.

Tom recommends not putting up a booth in Maybell so that he can devote his time to helping the film crew and their activities. The Board agreed.

- This project would use up most of the Projects Budget for the year.
- Question was can we do one to see how it works? Can we look at other signs that this company has already done?
- LMD might be a funding source for this project.
