#### Staff Reports:

## Road & Bridge Department - Bruce White

- Monthly Report:
- 1) Crusher We shut the crusher down for the winter on January 6. We have trained the crusher crew to fill in on various plow routes when we are shorthanded due to illness and scheduled time off among the regular plow operators. They are also utilized as CDL drivers in the winter to help alleviate staff shortages on the truck crew.
- 2) County Road 104 is an old part of state highway 40 that the county took over. Through the years, the asphalt has fallen apart and has had gravel placed over the top. The construction crew is ripping the old asphalt up with a dozer and pulverizing it with a sheepsfoot compactor. The truck crew is then covering it with fresh gravel. This will result in a much smoother traveling surface that is also easier to work.
- 3) The grader crew is plowing snow as needed. They are also constructing new racks to hang the motor grader wings on for the summer.
- 4) The bridge / mag crew has plowing snow on the paved roads. They have also spent 180 hours plowing the courthouse, Loudy-Simpson, Sunset Meadows, The library, the new courthouse and the road and bridge shop. With the help of the shop they also performed some needed repairs and reinforcements on the bridge on CR 1 in Slater Canyon.
- 5) Landfill Everything is running smoothly; the hospital demo is finished. Shane Kawcak and Dan Miller attended a Manager of Landfill Operations class for 2 days in Fort Collins. These classes are helpful in keeping up with the latest rules and regulations from the Colorado Department of Public Health and Environment.
