- Had two different Library Board meetings yesterday with Library Services. The Library Board is researching on how to make things work and are really trying to keep the Library going.

Public Comment:

Jennifer Holloway (Craig Chamber of Commerce) discussed the NACO sponsored Coal Community Challenge that she, Commissioner Beck, Andrea Camp, Terry Carwile, Tom Kleinshnitz, Rebecca Greenwood, and Drew Kramer recently attended in Denver. Three regional (NW Colorado) teams; 11 total teams from a wide-range of circumstances. Holloway feels that our community is so much better off compared to many of the other Coal Reliant Communities. 80% of the communities that this affects do recover after their facilities downsizes or closes. Looking to focus on Ag, Tourism and ways to support existing businesses. One idea that was presented was the "Co-Working" space concept for small-scale entrepreneurs and remote workers; possibly located in the library?

Ken Wergin commented on all of the deer carcasses (110) on the side of Hwy 13 heading north. He contacted CDOT about cleaning these up.

Jayne Morley requested that the BOCC reconsider the lack of funding for the Museum and the reduced funding to the Library.

Vicki Huyser questioned if the recent raise in property taxes could help with this funding. She would also like to see an amendment to exclude Turkey Vultures from being protected because they are such a destructive nuisance.

Beck commented that he would like to see a joint partnership between the City and the County to fund the Library and the Museum. He also discussed the many items that the County is tasked to maintain under the existing budget.

Bryson Davis gave a recap of this year's Youth Summit

Commissioner Broom commented that both the Library and the Museum are very important, and hopes that when they get into the next budget process that they will be able to adjust the funding.

Updating Building Codes (first hearing)

Tipton gave a brief background on the regional building department. Eckhoff spoke about the International Building Codes; Moffat County currently operates under the 2006 codes, the proposal is to upgrade to the 2018 codes by January 1, 2020.

5) YVEA "Operation Round Up" Grant application for Loudy-Simpson Park electrical infrastructure upgrade

Tipton presented a grant application to YVEA "Operation Round Up" for Loudy-Simpson Park electrical infrastructure upgrade. This is a project that has been needed for several years, and the electrical infrastructure would require a \$200,000 upgrade. If we were to receive this grant, it would be used for matching money for larger grants, probably from GOCO. The project would also run power in different locations for vendors during special events.
