Terms of a water supply contract to lease River District water from Elkhead were presented. Both contracts are the first step to completing an Augmentation Plan to allow residential water development in response to the State's Over Appropriation of the Yampa River. Tri-State donated \$25,000 to offset water lease costs for the first 10 years.
