## **Staff Reports:**

## Department of Human Services - Dollie Rose

Rose presented the minutes from February for approval.

Moe made a motion to approve the minutes for February 20, 2018. Cook seconded the motion. Motion carried 3-0.

Mindy Curtis in attendance

Rose reviewed department updates. She stated they continue to have 7 certified foster homes. There are 2 more that are still in the process. There is a Foster Parent appreciation dinner April 7<sup>th</sup>. Rose stated they have started taking walk-ins for their eligibility programs. They are doing this to help improve efficiency and effectiveness of public assistance in Moffat County. This is also in accordance with Senate bill 16-190.

Rose presented the electronic transactions.

Cook made a motion to approve the electronic transactions for January in the amount of \$305,389.88, for the Department of Human Services. Moe seconded the motion. Motion carried 3-0.

Rose reviewed the monthly reports.

## Finance Department – Mindy Curtis reporting:

Beck read the proceedings for a supplemental budget hearing.

Tom Kleinschnitz and Linda Peters in attendance

Curtis discussed the March supplemental budget. Beck asked the public if there was anyone to testify on behalf or against the supplemental budget the required three times.

Cook made a motion to approve Resolution 2018-38 March 27, 2018 supplemental budget. Moe seconded the motion. Motion carried 3-0.

# Human Resources Department - Lynnette Siedschlaw

Amanda Tomlinson in attendance

Commissioner Moe stated as a sitting County Commissioner and candidate for re-election he is recusing himself from the discussion and vote on the County Clerk and Recorder's personnel

requisition due to a conflict of interest. Siedschlaw discussed the request with help from Tomlinson and Raschke. Siedschlaw stated the office had an employee resign effective March 4<sup>th</sup>. This is a full-time budgeted position. Raschke read a letter she sent to the Board of County Commissioners on her behalf. Raschke also stated cleaning the office has become an issue. It has been difficult to find time to get it cleaned adequately. Tomlinson reviewed numbers from the Clerk and Recorder's office. Cook stated he is really struggling with approving this position. Cook stated when they set their policies last year, one of the ways they were going to try to help balance the budget through attrition.

Beck made a motion to approve the position for Motor Vehicle Technician. Cook seconded the motion. Beck discussed priority based budgeting and why he wanted to approve the requisition. He is looking at what is best for Moffat County as well as each department. Beck also wanted to state that his vote today is not precedence to future votes. Cook stated his definition is a little different than Beck's definition of priority based budgeting. Cook's suggestion is to look into a half-time position. Motion tied 1-1. Moe withheld from the motion.

Ponikvar asked what the controversy with Moe withholding from the vote is. Cook stated there are other circumstances. Ponikvar stated there is no financial conflict. Cook stated he felt that this was inappropriate at this time to question.

Siedschlaw presented the requisition for Colorado Community Response Coordinator for Human Services. Siedschlaw stated this position was just extended from one year to five years. This position is funded 100% through the State. Siedschlaw would like to start the position at 32 hours a week with benefits for four years. Cook asked if there was any cost to the County with this position. Rose replied there is no cost to the County. Rose stated this position works with clients before they go into the child welfare system. This program should decrease current child welfare clients.

Moe made a motion to approve the requisition for Colorado Community Response Coordinator for Human Services. Cook seconded the motion. Cook wanted to address that he only accepted the approval because there is no cost to the County. Beck asked Rose if there is money that we don't utilize: does it go to other counties? Rose responded yes, any money not used will be dispersed to counties that are over utilizing. Cook would like to see a comparison down the road of how this program is helping. Motion carried 3-0.

## Moffat County United Way - Amanda Arnold

Arnold presented the 2018 funding for Moffat County HRC. Arnold stated they received \$20,000 from the City and \$20,000 from the County. They also dipped into reserves for \$2500. There is now only \$2000 in the reserve account. Beck stated this program is a well vetted program. Arnold stated the board members of HRC are herself, John Ponikvar, Ray Beck, Pat Jones, Audrey Anna Masterson, Janelle Oberlander, Joel Sheridan and Shirley Stehle. Moe wanted to thank everyone on the board for their participation.

## Moffat County Broadband Initiative - Michelle Perry Balleck

Balleck gave an update of where Craig Moffat Economic Development Partnership is with Broadband. Last year they completed a plan with NeoConnect to give them a baseline of where to start to move forward with broadband. Balleck stated today they are asking for a commitment of \$12,500 from the County for to match against the City of Craig. This will fund the scope of work that was presented by Mammoth Networks to do the final design and engineering. If they can get this commitment there will be a 90 day projection on completing the final design and engineering. The State recently allocated \$115,000,000 from the High Cost fund to broadband from telephone services. Balleck stated that the EDA also heard from Congress that they have approved Coal Affected Communities funding again this year. Balleck presented the slideshow for Mammoth Networks and what their plan is moving forward. The implementation plan has the City of Craig owning the project with Mammoth Networks operating it. Duran stated the committee is so close to getting where we need to be. He stated with this commitment, it can get the County where it needs to be. The County will benefit along with Mammoth and the State of Colorado.

Cook made a motion to support the Network Operator Contract for \$12,500. Moe seconded the motion. Cook wanted to amend that this would be coming out of the County Development fund. Motion carried 3-0.
