Partnership

Armstrong Consultants has been working with Moffat County and the City of Craig at the airport since 2008. We have been privileged to work with both government entities on making improvements to the airport.

The ongoing challenges presented by the current government funding process have required a considerable amount of communication and effort to keep all of the projects on line. But we're happy to report that progress at your outstanding airport is proceeding as planned.

Projects Completed

The first project that was completed was in **2008/2009**. The new airport terminal building was constructed and the old one was torn down. This was a huge improvement

to the airport and to those that it serves. The new 1,340 square foot terminal building was constructed at a cost of \$241,555 which the local funds paid for approximately \$15,000. This is a great upgrade for the airport. The project was constructed by Domson Excavating who purchased the building form local manufacturer Kozy Homes, Inc.

In 2009, Armstrong again worked with the local Airport Board, Moffat County and City of Craig to overlay the existing pavement in front of the newly constructed airport terminal building. The project was funded again by FAA, CDOT Aeronautics and local funds. The

project was completed by Connell Resources. The project was completed for at a cost of \$128,974.44. The local cost was approximately \$3,951.44

The latest project that was completed at the

airport was in **2010**. A pavement maintenance project that consisted of an asphalt rejuvenator and remarking of the runway, taxiways and apron was completed. The project was completed by Hi-Lite Marking at a cost of \$107, 637.10. The local funds required for this project were \$3,508.41.

Future Projects Craig Moffat County

The Craig Moffat County Airport will continue with the maintenance with reconstruction of the apron in 2013. The apron will assist with

aircraft circulation and parking during peak periods of traffic.

The FAA money is being 'banked' or 'carried over' to save for this construction.

Armstrong Consultants has successfully completed several apron expansions in Colorado including Kremmling, Fremont County, Wray, Burlington and Delta to list a few.
