Becky Copeland -

- Harm Reduction Updates (NarcX, lockboxes, Narcan trainings, etc)
 Copeland brought samples of the Harm Reduction kits, lockboxes, etc. and explained their functions.
- Opioid or Overdose Fatality Review Updates
 One case has been reviewed so far. Several valley-wide agencies have participated.
- Sex Ed Updates
 The Public Health Department has taken over the Sex Ed program for the schools.

Selene Cooper -

- Child Safety Program Updates Many items are provided to the public under this program: life jackets, helmets, outlet covers, cabinet locks, and if a referral comes through, car seats.
- Hygiene Kit Program Updates "Hygiene packs" for the middle and high school kids are provided through the school nurses office, along with snacks for diabetic situations.
- Car Safety Program Updates They are working stocking car safety buckets. Blankets, gloves, hats, snacks, etc. Because of supply chain issues, those will not be available for distribution until next winter.

Amanda Pipher -

- Community Health Assessment Plan (CHAPS) Program Updates Every five years, they are required to complete the CHAPS process, which they have contracted out to a company called BioDefense. This was paid for by a grant. From the plan, they build the Public Health Improvement Plan, which is down to the rough draft potion.
- Basic Life Saving Class Update Classes have been held (so far) for day care providers and County employees. The class is free for County employees and a charge will be required for the public at large.

Grants Update

Did not get the Harm Reduction grant (too competitive). They did get the Gun Violence grant for \$10,000.

Todd Wheeler -

> AED Policy and Procedure (BPH Resolution 2023-01) (see attached)

The development of this policy has been in the works for the last year. There will be twelve AED units distributed around various County facilities. There is an ongoing process to purchase more units. The resolution adopts the policy.
