Natural Resources Department – Jeff Comstock

Present final version of Potential Socioeconomic Impacts of the Craig-Hayden Pumped Storage Project report (see attached)

Comstock presented the final version of Potential Socioeconomic Impacts of the Craig-Hayden Pumped (closed loop) Storage Project report, and asked the BCC to make a motion accepting it. This project (when approved) would be on the east end of Moffat County, right on the county line with Routt County, would create 600 megawatts of power, and should take about six years to complete. rPlus Energies (the contractor) hired SWCA

to do this study. The study covered tax revenue impacts, jobs, water use, workforce & workforce housing. There would be on average 500 workers on the construction side of the project, with 35 on-site permanent employees after completion. It has the potential to generate \$1.4 million in property taxes.

Matthew Shapiro and Lars Dorr, both with rPlus Energies, appeared by ZOOM. Steve Hinkemeyer, chairman of the Land Use Board, also came up and commented about aspects of the project.

Broom moved to accept the final version of Potential Socioeconomic Impacts of the Craig-Hayden Pumped Storage Project report. Villard seconded the motion. Motion carried 3-0.

Yampa River Leafy Spurge Project - John Husband

Program update

Husband made introductions from the audience - Jesse Schroeder (Moffat County Weed & Pest) and Tamara Nauman, who joined him for the presentation. He also presented a slide show detailing the history behind & the work of the Yampa River Leafy Spurge Project, their partners and volunteers, to eradicate the invasive Leafy Spurge plant along the Yampa River.

Emily Spencer (Dinosaur National Monument) and Ben Beall appeared by ZOOM.

Northwest Loan Fund - Anita Cameron

- Program update
- Community Development Block Grant application (see attached)

Cameron presented a Community Development Block Grant Application packet for signature. The Northwest Loan Fund is responsible for generating business loans for the nine northwest counties in Colorado. These loans are used to create jobs and stimulate the economy in these counties. Catherine Blevins with Yampa Valley Bank, who is the local representative for the Loan Fund committee, also participated in the presentation. The grant money comes out of HUD at the Federal level, but they are managed at the State level. The State provides 16% on top of the grant, which is used for administration fees. The recent grant is \$5,159,898 and the money is usually available in around six weeks depending on the volume of applications. During the last grant process, Cameron secured about \$3 million in loans, 24 loans were made, which helped to create 87 jobs.

Broom made a motion to approve signing the Community Development Block Grant application and the Intergovernmental Agreement. Villard seconded the motion. Motion carried 3-0.

We understand that MRH is interested in applying for a Colorado Energy Office Geothermal Energy Grant and/or a CEO Geothermal Energy Tax Credit Offering. These requests will assist MRH in moving toward energy efficiencies (geothermal) that will reduce annual operating costs. Considering the Moffat County Board of County Commissioners approves the MRH budget and appoints its Board of Trustees, this grant is a win-win for both the Hospital, as well as the taxpayers of Moffat County.

MRH has experienced inefficiency in its existing traditional heating and cooling system and the backlog for parts and available labor in an HVAC system of this size and type has created a need for a more reliable solution. A well-designed feasibility study for geothermal climate control may be that solution. MRH leadership has connected with reputable industry experts in the heating and cooling industry, and analyzed similar systems next door at the Colorado Northwestern Community College campus, as well as facilities in Gunnison County, Co. The medical campus includes the MRH hospital, a medical office building, and future emergency medical services (EMS) station and training center.
