Public Comment/General Discussion:

Karen Stillion, with CASA (Court Appointed Special Advocates for children) came up to remind the BCC about the upcoming CASA/Legislative dinner that is being held on July 26 at a board member's house. Of the three regions in the 14th Judicial District, Moffat County has the most clients in this program.

Allison Anthony gave an update to the BCC regarding new voter information from across the country.

Staff Reports:

Human Resources Department - Rachel Bower

Discuss Employment Offer for Veteran Services' Officer position (see attached)

Bower presented a request to the BCC to add an additional part time (20 hours per week) VSO position. This proposed position has been reviewd by the State and is approved to be reimbursed up to 40 hours. Adding a second VSO position will help improve accessibility for our veterans, ensure consistent coverage, and overall help us to better serve the veterans that have served us.

Two interviews for the original position were held on June 30th and July 1^{st.} The second position will be posted internally for an additional week to allow existing employees an opportunity to apply. Bower requested BCC approval to extend an employment offer to fill the current VSO vacancy. And, possibly, after the passing of the internal posting, the added position. Bohrer commented that he would prefer to wait until the July 22 meeting to approve any job offers.

Bohrer moved to approve the addition of a (part time) second VSO position. Broom seconded the motion. Motion carried 3-0.

8:45 am - Public Hearing:

Villard read the Public Hearing protocol and declared the Public Hearing open.

Planning & Zoning – Candace Miller

▶ Hampton Conditional Use application C-25-05 (see attached)

Miller presented the Conditional Use application for Stephen Hampton for a home-based business. The applicant was able to answer all the requirements for the business and all adjacent property owners were notified by mail; there was no response from any of the neighbors. The Planning & Zoning Commission reviewed this application at their meeting last week and approved it with no stipulations.

There was no public comment.

In regular session, Broom moved to approve the Hampton Conditional Use application C-25-05. Bohrer seconded the motion. Motion carried 3-0.

Segura Conditional Use application C-25-07 (see attached)

Back in Public Hearing, Miller presented a Conditional Use application for Thomas and Amy Segura for an additional dwelling for in-laws. This dwelling will share the same address and use the existing property access. The applicant is working with the building inspector on building permits, septic, etc. The Planning & Zoning Commission reviewed this application at their meeting last week and approved it with no conditions.

There was no public comment.

Back in regular session, Broom moved to approve the Segura Conditional Use application C-25-07. Bohrer seconded the motion. Motion carried 3-0.

Assessor's Office - Larona McPherson

Yearly Assessor's report (see attached)

As required by state statute, the Assessor must report to the County Board of Equalization no later than July 15th of each year.

McPherson reviewed the following:

- 2025 Real Property Protest period 265 protests filed; 241 residential; 24 vacant land; 110 adjusted; 155 denied
- No personal property protests
- One CBOE protest (residential) that will come before the Board of Equalization

There was also discussion about the state level Senior Property Tax Exemption program. McPherson said it was highly likely that the state would be doing away with that. The BCC asked if it would be possible for the County to implement a county level Senior Property Tax Exemption program? McPherson said she would look into it.

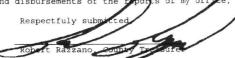

INTERGOVERNMENTAL AGREEMENT

This Intergovernmental Agreement, is made between the Board of County Commissioners of Moffat County, Colorado, (hereinafter "County") and the City of Craig, Colorado (hereinafter "City").

Recitals and Definitions:

- A. The Airport is owned and operated by Moffat County with financial support from the City as appropriated by City Council on an annual basis.
- B. The parties are signatories to documents entitled "Operating Agreement and Authority for the Craig-Moffat Airport" executed by City on March 30, 1983 and executed by the County on March 29, 1983; and "Agreement and Lease" executed by the City January 3, 1984 and by the County on January 10, 1984. By execution of this Intergovernmental Agreement, the above-mentioned agreements are considered null and void.
- C. The operation and control of the Airport includes the possibility of negotiating leases, licenses, concessions, or other business relationships and agreements with third parties (hereinafter collectively called "Leases") whose operative terms will or may extend beyond the operative terms of this agreement (or any extension hereof).
- D. The County has been operating the Airport since at least January 1, 1984, and has been primarily responsible for expenses related to the operation, maintenance and improvements of the Airport since 1996.

NOW THEREFORE, for and in consideration of the above Recitals and the mutual promises, covenants and agreement of the parties, AGREE:

- 1. The County, through the Board of County Commissioners, shall continue to operate, maintain and control all aspects of operations, maintenance and improvements of the Airport, and in doing so; the County must be able to negotiate Leases, and those who deal with the County must be assured that such leases will be honored. The County will manage the Airport in such a manner as to maximize potential revenues as much as is reasonably possible.
- 2. The County, through the Board of County Commissioners, shall apply for and maintain all Federal Aviation Administration and Colorado Department of Transportation grants, loans and airport funds administration documents for the Airport. The City will support the County as necessary and as staff time allows in application for any grants.
- 3. The City agrees to share in support of the Airport financially and with in-kind expenses associated with the management and operation of the airport, as necessary

and as agreed to by the City. The City and the County shall agree in writing, and on an annual basis (by November 1st of every year), regarding the specific expenses the City will contribute to for purposes of supporting the airport. The parties agree the financial contribution of the City is contingent on annual budget approval by City Council for expenses associated with the airport and the City's ability to appropriate necessary funds to support a shared cost of the Airport. The County will submit expense and revenue reports to the City on a monthly basis. The County will invoice the City quarterly for its share of the agreed upon airport operating and personnel expenses. The City will pay the invoices within thirty (30) days of receipt. The City will endeavor to support the Airport financially in all future years as requested and shall make all good faith budgetary efforts to share in the support of the Airport.

- 4. <u>Creation of the Airport Advisory Board:</u> The Airport Advisory Board shall consist of five (5) members to act in an advisory role to the Board of County Commissioners and City Council. Two (2) of the members shall be appointed by the Board of County Commissioners; two (2) members shall be appointed by the City Council; and one (1) member shall be mutually agreed upon by both parties. One (1) member of the Board of County Commissioners and/or One member of the City Council will serve as the Ex Officio to the Advisory Board as a non-voting member.
 - a. Term of Office shall be for three (3) years with appointments being staggered over the three (3) year term;
 - b. The membership of any member who fails to attend three (3) consecutive scheduled meetings without due cause shall automatically terminate;
 - c. Board vacancies shall be filled pursuant to the provisions of paragraph 6 herein.
 - d. The Airport Advisory Board shall adopt bylaws to be followed by its members within 60 days of its first 2025 Meeting.
- 5. <u>Duties of the Advisory Board</u>: In additional to any other duties stated herein, the Advisory Board shall:
 - a. Provide general advice to the Board of County Commissioners and the City Council;
 - b. As needed, prepare additional policies, rules or regulations for the safe and efficient operation of the Airport and make recommendations to the Board of County Commissioners for their consideration and approval;
 - c. Review the Master Plan for the Airport every five (5) years or as required by the FAA and present this information with the proposed budget for the Airport;
 - d. Each year, at the September meeting, the Airport Manager shall submit a proposed budget for the consideration of the parties. The parties and the Advisory Board may meet and consult together to determine the final budget;

- e. From time to time, an evaluation shall be made of the possible Airport revenue sources. Specifically, but not by way of limitation, these may include tie-down, hangar, and registration fees. It shall be appropriate to consider whether the facility or equipment used is owned and/or maintained by the County or whether it is owned or independently leased by the person, firm or corporation utilizing it. The Advisory Board and the parties shall look to all facts and circumstance in determining what such fees, charges and rates should be so that they are equitable, both as between the business operators, concessionaires or lessees and the public but also as between competing businesses operating on the Airport.
- 6. <u>Continuity of and Vacancy on Advisory Board</u>: Upon the passage of the appropriate resolution or ordinance by the parties and the execution of this agreement, the existing members of the Advisory Board shall continue in their appointment to the Advisory Board being deemed the appointee of the party who originally appointed such person. In the event of a vacancy on the Advisory Board, the appropriate party shall recommend the name of a person, or persons, to fill such vacancy, but the appointment shall be made by the City or the County depending on the available seat. Appointments to fill vacancies shall be for the unexpired term of the member creating the vacancy, and all new members shall be appointed for a term of three years (3) years. Terms shall be staggered.
- 7. <u>Minutes of the Advisory Board</u>: The Advisory Board shall cause accurate minutes to be maintained concerning its acts and recommendations. Copies of these minutes shall be submitted to the Advisory Board for consideration at their next regular meeting.
- 8. <u>Term of the Intergovernmental Agreement</u>: This agreement shall begin on the 1st day of August, 2025, and shall continue for five (5) years with an option to renew for an additional five (5) years thereafter so long as the City and the County pass a resolution through their respective board/council to extend the agreement prior to the date upon which the agreement would expire.
- 9. <u>Purpose of Agreement</u>: The County shall use, keep and maintain the Airport as and for a public airport facility and if, at any time during the term of this agreement, the Airport shall cease to be so used, then and in that event, this agreement shall terminate and be of no further force and effect.
- 10. <u>Hold Harmless</u>: During the period of this Agreement, the County shall keep and maintain the Airport and hold the City harmless from any and all claims, actions and demands of any kind or nature arising out of the operation and maintenance of the Airport.
- 11. <u>Ratification of Leases:</u> The County shall have the power to negotiate and execute Leases.

- 12. <u>Exclusion Concession or Use</u>: As to any facility or improvement at the airport, the same shall be dedicated and used for the benefit of the public as a whole and although the same may be leased to a business, such lease shall specify the services offered by such business and using such facility of improvements shall be available to the public at large. As to the Airport as a whole, no exclusive concession, license or lease agreement may be granted to any business.
- 13. <u>County Airport Funds</u>: All funds derived from the operation of the Airport, together with the share of the budget to be contributed by the parties shall be credited to the County Airport Fund, and all charges for the operation, maintenance and capital of the Airport shall be paid from said fund. Note: Capital portion of fund to commence in the year 2025.
- 14. <u>Guidelines and Goals</u>: The parties desire that the Airport is an asset to the City and the County, and its facilities be available to the public for the greatest number of hours and for the largest number of needs consistent with the profitability of the operator, business, licensee or lessee. The parties recognize the legitimate public need for encouraging these objectives. The Advisory Board shall use all its best efforts to encourage and further the availability of all aviation required services, both for the public at large and also for general aviation and commercial air carrier service, if possible.
- 15. <u>Rules and Regulations</u>: The Advisory Board shall consider and recommend to the parties the adoption of rules and regulations for the operation of the Airport. After adoption, the Board of County Commissioners shall strictly enforce the provision of this agreement and all such rules and regulations.
- 16. <u>Approval of Improvements</u>: The Advisory Board shall review and make recommendations to the Board of County Commissioners and the City Council prior to construction, improvements and additions made on the Airport, and shall specify and prescribe the type of improvements allowed to be constructed on the property. The Board of County Commissioners shall have final authority with respect to improvement after input from the Advisory Board and the City. Only budgetary items would go the City for approval during the annual budget review. Decisions to adjust billing, rules, regulations, etc. would be approved by the county.
- 17. <u>Notices</u>: Any notice required hereunder shall be in writing and shall be mailed or hand delivered to each of the following addresses, directly to the attention of the person indicated or such person as may hereafter be indicated:

Either party may change the name or address, above, by written notice to the other. Notice shall be effective two (2) days after the same has been deposited, certified, and postage prepaid in the United States mail.

- 18. <u>Ownership of Improvements</u>: During the term of this Agreement, the County may choose to improve, expand, remodel or otherwise modify the existing improvements owned by the parties located upon the Airport. It may also choose to construct additional improvements. The County retains ownership of all runways, taxiways, public use hangars, buildings, equipment, or other permanent airport infrastructure located on the property are sole property of the County.
- 19. <u>Intergovernmental Cooperation</u>: This agreement is being entered into and approved by the respective elected representatives of each of the parties hereto, and is authorized as an Intergovernmental Agreement by Article XIV, Section 18, Colorado Constitution, and C.R.S. § 29-1-201, *et, seq.*, thereby conferring upon the County the full authority to perform the essential public service required by this agreement.
- 20. <u>Termination</u>: Either party may terminate this agreement for cause and shall give the other party thirty (30) days written notice of its intent to terminate.
- 21. <u>Non-Appropriation</u>: Each party hereto agrees that the revenues and expenditures hereunder shall constitute current expenditures and revenues payable and receivable in the fiscal years for which funds are appropriated for the payment thereof. The obligations of the parties under this agreement shall be from year to year only and shall not constitute a multiple-fiscal year direct or indirect debt or other financial obligation or any obligation payable in any fiscal year beyond the fiscal year for which funds are appropriated for the payment thereof or payable from any funds other than funds appropriated for the payment of current expenditures. No provision of this agreement shall be construed to pledge credit or to create a lien on any class or source of either party's monies. Notwithstanding any termination, the County shall remain liable for any amounts for prior services provided and not paid.
- 22. <u>Inspection</u>: The City shall have the right to inspect the Airport and the improvements thereon at reasonable times.
- 23. <u>Insurance:</u> The County is a Public Entity under the Colorado Governmental Immunity Act, C.R.S. 24-10-101, *et seq.*, as amended, and shall always during the terms of this agreement maintain such liability insurance, by commercial policy of self-insurance, as is necessary to insure the Airport and to meet its liabilities under the Act. This insurance shall have minimum limits, which shall match or exceed the maximum governmental liability limits set forth in C.R.S. 24-10-114, as amended.

- 24. <u>Payment/Reimbursement</u>: The City will reimburse the County one-half of the agreed upon costs for operations, maintenance and improvements of Airport on a quarterly basis. Payment will be made to Moffat County, 1198 W Victory Way, Craig, CO 81625.
- 25. <u>Binding Agreement</u>: This agreement shall be binding upon the parties and their successor in interest.
- 26. <u>Miscellaneous Provisions:</u>
 - a. <u>Entire Agreement</u>: this document constitutes the entire agreement between the parties regarding the City's annual funding commitment for the Airport. Any amendments must be in writing and signed by both parties.
 - b. <u>Relationship of Parties.</u> It is mutually agreed and understood that nothing contained herein is intended or shall be construed as in any way establishing the relationship of co-partners or a joint venture between the City and County, or as construing the County, including its officers, agents, volunteers and employees, as an agent of the City, or as construing the City, including its officers, agents, volunteers and employees, as an agents, volunteers and employees, as an agent of the City.
 - c. <u>No Third-Party Beneficiaries.</u> None of the terms, conditions, or covenants in this Agreement shall give or allow any claim, benefit, or right of action by any third person not a party hereto. Any person other than the City or County receiving services or benefits under this agreement shall be only an incidental beneficiary.
 - d. <u>Severability.</u> The parties understand and agree that if any part, term, or provision of this Agreement is by the courts held to be illegal or in conflict with any law of the State of Colorado, or of the United States of America, the validity of the remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Agreement did not contain the particular part, term, or provision held to be invalid.
 - e. <u>Waiver</u>. No waiver of any breach or default under this Agreement shall be a waiver of any other or subsequent breach or default.
 - f. <u>Governing Law and Venue</u>. This Agreement shall be governed and construed in accordance with the laws of the State of Colorado. Venue for any action arising under this Agreement shall be in Moffat County, Colorado.

Lease in Effect. The Lease (i) has been duly executed and accepted by Landlord and Grantor, (ii) is in full force and effect, and (iii) has not been modified or changed, either in writing or orally, except as reflected in the copy of the Lease provided to Lender.

No Default. As of the date of this Certificate, (i) all conditions and obligations to be performed by either Landlord or Grantor under the Lease, to the date hereof, have been satisfied; (ii) there exists no breach, default, or event or condition which, the giving of notice or the passage of time, or both, would constitute such a breach or default under the Lease; and (iii) there are no existing claims, defenses or offsets against obligations of either Landlord or Grantor under the Lease, including any against rents due or to become due under the terms of the Lease.

With the high cost of new equipment, we have decided to start refurbishing equipment with certified rebuilds whenever possible. We have a 1989 D-6 Caterpillar dozer that was due for replacement this year. Rather than replacing it, we want to get it rebuilt.

A complete rebuild by Wagner Equipment in Hayden is estimated to cost \$207,514.26. The rebuild will come with a 5-year, 5,000-hour warranty. Enclosed is a list of components included on the rebuild.

For comparison, the last dozer we purchased was a slightly used D-7 in 2021 that cost us \$581,737.00. The last D-6 we purchased was a 2007, which cost us \$271,975.00. The 1989 that we want to rebuild was \$124,763.00. We have gotten 36 years of use out of this dozer and we think this will extend the life another 20 plus years.

I would like to ask the commissioners to waive the bid process for the rebuild of the 1989 D-6 dozer.

If we have enough savings in the capital budget this year, we would like to get the 2007 D-6 rebuilt as well.
