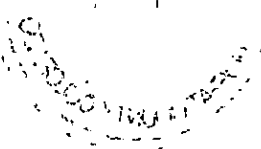

The Board signed off on this document as the BOCC (under the County Department of Human Services), then after reconvening as the Board of Public Health, signed as that entity.


Broom made a motion to approve signing the Collaborative Management Memo of Understanding. Beck seconded the motion. Motion carried 3-0.


